COREY DRILLING TO RESUME - Kenneth W. Trociuk, president of Kenrich Mining, has reported a 15 drill hole program is planned to start Aug. 25, 1996 at the 100% owned Corey project 70 km. north of Stewart, NW BC. (See map overleaf P.2) Detailed mapping and trenching on the TV Zone within the Corey area has revealed a high grade silver zone containing pyrargarite (ruby silver) hosted in black shales. Trench sampling has returned:

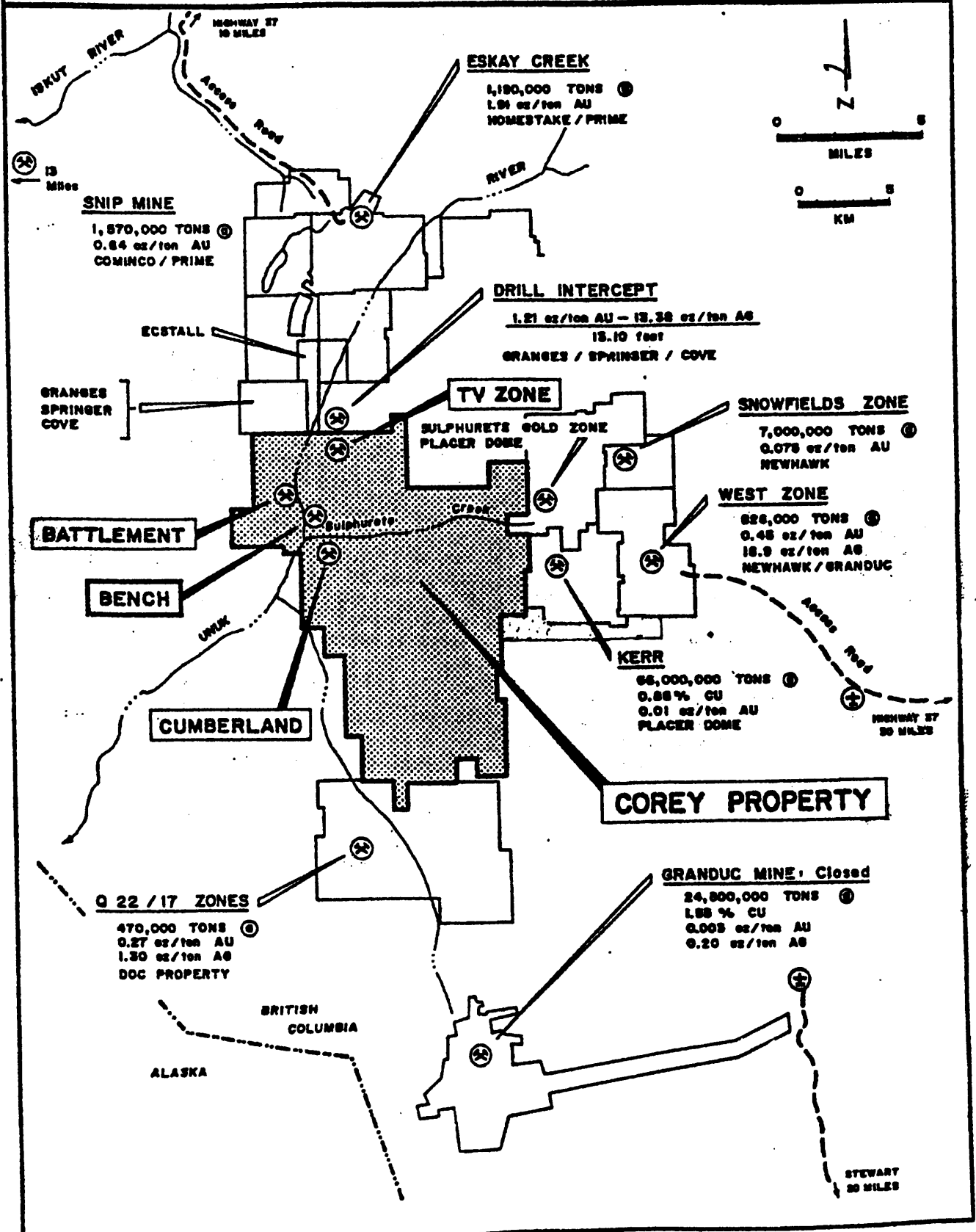
